NOTE: Resident family members 23 years of age or older who are not the property owner or their spouse must be listed here and are required to have an Associate Membership (see Line 3) and a family badge (see Line 5). Please read all instructions before filling out your dues statement

LINE 1 - FAMILY MEMBERS. List the names and birthdates (not ages) of all members of your permanent household who use Association facilities/property. If there are multiple surnames in the family, please indicate both first and last names. Family members who do not live with you should not be listed. If you are renting your property, you may choose to retain membership privileges for yourself OR pass them along to your tenant. If your tenant will be using the facilities, please provide names and birthdates for everyone living at your property (or have your tenant provide this information).

LINE 2 - MEMBERSHIP DUES. There are three types of active memberships. Note: Family badges are not included with your membership dues and must be purchased on Line 5:

- Standard (Regular Active Membership) - Full dues are owed.
- Senior Citizen (65) - Members age 65 and over, on or before March 1, in good standing for the previous five years, shall have their annual dues reduced by 50% commencing with the fiscal year following their 65th birthday.
- Senior Citizen (80) - Members age 80 and over, on or before March 1, in good standing for the previous five years, shall be exempt from the payment of annual dues commencing with the fiscal year following their 80th birthday.
 - To qualify for a senior discount for the first time, please supply proof of age.
 - To claim a senior discount, you must be the property owner or the property owner's married spouse.
 - A senior discount is available only if you are living at your property. If you are renting your property, full dues must be paid.
 - Qualifications above only applicable if you gained ownership prior to September 1 of 2022. All those after, please refer to the current Bylaws.

LINE 3 - ASSOCIATE MEMBERSHIP DUES. Family members 23 years of age and older who reside at the property (excluding the property owner and owner's married spouse) are required to have an Associate Membership. Age is as of March 1. The Associate Member fee of \$30 is in addition to the Standard or Senior Citizen Membership Dues. Note: A family badge is not included in this fee and must be purchased on Line 5.

LINE 4 - ANNUAL DAM ASSESSMENT. The annual Dam Assessment of \$245 must be paid by all Fayson property owners regardless of age.

BADGES/DECALS

LINE 5 - FAMILY BADGES. A family badge is required for every family member listed on your form, except children under the age of 6. Age is as of March 1. Badges must be worn at all times while on Association property. Family badges are not transferrable. Family badges should not be purchased for family members or other persons who do not live with you.

LINE 6 - GUEST BADGES. A guest badge is required for each member guest and must be punched by the badge checker upon entrance to the beach. Guests must be accompanied by a member. A maximum of 6 guest badges may be purchased (including grandchild badges). Guest badges may not be lent to other members or given to Fayson Lakes residents who are delinquent. Visiting grandparents or seniors wanting to watch children's events do not need to have a guest badge punched. A guest badge used by a babysitter watching a member's children does not need to be punched unless the adult member is also present at the beach. In special situations, a note may be used when a member is not available to sign in their guests (see the Beach Director).

LINE 7 - GRANDCHILD GUEST BADGES. Offered as a courtesy to our member grandparents providing alternative to a regular guest badge for visiting grandchildren ages 6-18. Age is as of March 1. Unlimited use; badges do not need to be punched. Grandchildren are considered guests and must be accompanied by a grandparent at all times; they may not sign in other guests. Visiting grandchildren may participate in beach activities (excluding participation in the Fayson Lakes Swim Club). Note: A maximum of 6 guest badges may be purchased (including grandchild badges).

LINE 8 - FISHING GUEST BADGES. This badge does not allow access to beach facilities and is to be used only when inviting a guest to fish with you in your registered boat. A guest using this badge must be accompanied by a member. A maximum of 3 guest fishing badges may be purchased. All state fishing laws are in effect.

As specified in our by-laws, "Persons fourteen years of age or older may not fish from the shore or docks" and "Senior Citizens and handicapped persons, who are Association members, may, for a nominal charge, apply to the Board of Trustees for a badge which will permit them to fish from the shoreline of Association properties". Please contact the office if you require the special badge that allows you to fish from shore.

LINE 9 - BOAT DECALS. A set of current year decals (2 per set) must be purchased for and clearly displayed on every boat used or stored on Association property. Please supply a brief description of each boat for which decals are purchased. Your decals will come to you marked with your boat registration number. In addition to displaying your decals, it is mandatory that every boat be clearly marked on both sides of the bow with its registration number. Do not rely on the decals to identify your boat. Note: Pontoon boat owners will be supplied with a separate registration form.
